A Special Report on Ending the Overrepresentation of Aboriginal Young <u>People Involved with the Child Welfare System</u>

Date: June 14, 2016

Time: 11:00 - 12:30

The Office of the Child and Youth Advocate and the Aboriginal community are advocating for systemic changes within the child intervention system through a special report and community forums related to the high percentage of Aboriginal young people in this system. "Our hope is that a new story is created for Aboriginal young people and their families involved with the Child Intervention system." Elder, Saddle Lake. In 2015/2016, the OCYA reached out to Aboriginal young people, elders, families, caregivers, and key stakeholders through focus group gatherings, interviews, and online surveys to hear from them what is important and helpful to Aboriginal young people before and after they are brought into care.

HcOM Operations & Support Sub-Committee Presents: eHealth Showcase



On May 19, 2016 TSAG and the HCoM Operations & Support Sub-Committee organized the first ever Alberta eHealth Showcase. This event was hosted at Siksika Health Services on the Siksika First Nation. The showcase focused on current eHealth programs in Alberta as well as upcoming initiatives happening in other areas of the country.

One of the key presenters at the event was Dr. Ivar Mendez. Dr. Mendez presented on **Remote Presence Robotic Technology to Provide Service to Remote First Nation Communities.** His presentation offered a look at new advancements in robotics in Saskatchewan as well as Newfoundland and Labrador. Dr. Mendez discussed clinical trials in the northern remote city of Nain. Nain is only accessible by plane and is approximately 350 km away from the closest town. Being so isolated has it's struggles; eventually the people of Nain reached out to the government and Dr. Mendez. With the hospital in Happy Valley Goose Bay and Dr. Mendez, Nain was given a robot named Rosie. Rosie is a mobile cart that is controlled by the doctor in the hospital. The doctor is able to move Rosie around the Nain Health Centre, treating patients and assisting Nurses with procedures.









Dr. Ivar Mendez is the Fred H. Wigmore Professor of Surgery and Chairman of the Department of Surgery at the University of Saskatchewan and Unified Head of Surgery of the Province of Saskatchewan.

Dr. Mendez has focused on, and significantly advanced, the use of remote-presence robots for medical care in neurosurgery and primary health care. In 2002, Dr. Mendez and his team performed the first long distance telementoring neurosurgery in the world. In 2010, his team established the first remote presence robotic program in the Canadian North to provide access to primary and specialized medical care to underserviced First Nations communities. Since 2013, he has been working with First Nation communities in Saskatchewan using advanced robotic technology for healthcare delivery.

For his pioneering work in the use of remote presence devices to deliver health care to underserviced populations, Dr. Mendez received the 2011 Health Canada Award for Contribution to the Improvement of the Health of Canadians. In 2012 he received the Queen Elizabeth II Diamond Jubilee Medal and was inducted as a fellow into the Canadian Academy of Health Sciences in 2014.

KTC Community Highlight

With the goal of increasing access to and expanding available healthcare programs and services to our community members living on-reserve in our semi-isolated communities, KTC worked diligently with their member Nations to implement Clinical Telehealth Services from their local Health Centres. Loon River First Nation, Woodland Cree First Nation, and Whitefish Lake First Nation #459 have been operational since 2012. Peerless Trout First Nation & Slave Lake Apple Drugs Suboxone Program commenced in 2015. Lubicon Lake Band is working towards implementation in the future.

Currently KTC Health Centers and Clinical Telehealth programs offer support to onreserve community members through clinical sessions, educational sessions and business purposes. Clinical sessions include medical, specialist, family support and follow up appointments.

Our Suboxone Program at Slave Lake Apple Drugs utilizes Clinical Telehealth to provide physician screenings and follow up appointments without having to travel far into the urban centres.

Clinical Telehealth Services is not intended to, nor has not replaced the in-person visits, but instead has enhanced existing services and provided access to services off site.

For decades, our member Nations have struggled to entice, recruit and to retain specialized service providers including nurses, physicians and specialists on reserve. Since the implementation of the Clinical Telehealth Program, the health outcomes of our members has certainly improved.

We have been able to decrease travel and travel times for clients and physicians, lowered transportation costs, and reduce client wait times for appointments. In 2015-2016 fiscal year, our Clinical Telehealth Program has already delivered over 200 consultations and Physician utilization has increased since 2012. "We continue to work on expanding services and usage in the communities; increased usage means increased access to services". – Kirsten Sware, Director of Health, KTC Administration

Under The Microscope with Dr. Sarin



Welcome back to *Under the Microscope*. The last column discussed Harm Reduction approaches to the Fentanyl Crisis. Since that time, the Fort McMurray wildfire fire crisis has had a profound impact on the city, the surrounding First Nations and every Albertan. Our thoughts are with all residents of Fort McMurray and the nearby First Nations communities as they begin the process of returning home. We are hopeful that some normalcy returns to the lives of the individuals who had to deal with this period of chaos and uncertainty.

This month, the Telehealth Newsletter presents the highlights of a meeting that recently occurred at the Siksika Health Centre. TSAG, the First Nations and Inuit Health Branch, and First Nation representatives had the opportunity to learn what eHealth activities are occurring throughout Alberta. It was a very exciting and busy day and there were many great presentations and discussions. We hope the momentum from this meeting supports efforts to keep the First Nations Telehealth Network strong and vibrant. We are implementing a Strategic Plan and hope to see Telehealth activity expand dramatically in the next few years.

We are very proud of the First Nations Telehealth Network, but clearly see the limitations that fixed (permanent, non-mobile) sites impose. Our neighbours in Saskatchewan are implementing Remote Presence Technology under the leadership of Dr. Ivar Mendez. Dr. Mendez explained how technology can be used to provide health services on-reserve. Some examples of this might include, a robot controlled by an operator hundreds of miles away, or a Doctor in a Box that "travels" with a nurse to a patient's home. Attendees at the Siksika meeting were treated to a live demonstration of several of the robots that have been deployed throughout Saskatchewan. It is truly amazing what technology can do. You have to see it to believe it. It was an honour to meet and engage with Dr. Mendez and see his deep commitment to innovation and to Canada's indigenous peoples.

We have a busy last month before the summer and look forward to connecting with you at the upcoming sessions.






Telehealth Word Search

First Nations Telehealth Network sat down with our very own, Amal Hassen. Read below to find out more about her involvement with the network!

What is your role within Telehealth?

My role with the First Nations Telehealth Network is as the Telehealth Project Officer. In my position I work with our partners in FNIHB, Alberta Health Services and local organizations to develop educational sessions that can be delivered via videoconference to Health Centres on reserve. In addition, I compile statistics on Telehealth usage to help identify opportunities to enhance service delivery.

What do you think the benefits of Telehealth are?

Telehealth helps to connect people. Regardless of location, it allows for anyone to access clinical or educational services that might otherwise require considerable travel. Telehealth isn't meant to replace but enhance existing services. As our programming is community driven, it allows for individuals to get what they want, when they want.
